Nomination papers must be delivered to the Deputy Returning Officer, Pathfinder House, St Mary's Street, Huntingdon, PE29 3TN on any day from the date of this notice but no later than 4 pm on Thursday, 8th April 2021. Nomination papers may be delivered any working day between 9 am and 5 pm. 3. If any election is contested the poll will take place on Thursday, 6th May 2021.
4. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Monday 19 April 2021. Applications can be made online: <https://www.gov.uk/register-to-vote>
5. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at Pathfinder House, St Mary's Street, Huntingdon, PE29 3TN by 5 pm on Tuesday, 20th April 2021.
6. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Pathfinder House, St Mary's Street, Huntingdon, PE29 3TN by 5 pm on Tuesday, 27th April 2021.
7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at Pathfinder House, St Mary's Street, Huntingdon, PE29 3TN by 5 pm on Thursday, 6th May 2021. The physical incapacity must have occurred after 5 pm on Tuesday, 27th April 2021. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5 pm on Tuesday, 27th April 2021.
